Meeting Minutes, May 31st, 2018 at Lee Lake Tavern

Meeting called to order by Club President Arlyn Libal with 21 members present.

Secretary's Minutes: Motion made by John Campbell to approve minutes from last meeting as printed, seconded by Earl Macha. Motion carried.

Treasurer's Report: Motion made by Pam Lemorande to approve treasurer's report as read, seconded by Dan Brokiewicz. Motion carried.

K.L.S.C Gun Banquet (chairman) Arlyn Libal: Gun Banquet took place on Thursday May 3rd at Romy's Holiday Inn. Thank you to Rick Kozlovsky for taking care of the gun purchases, club received a lot of good comments on the number and quality of guns this year. Question from John Campbell as how the 50/50 raffle is run was discussed. His concern was, if monies awarded over \$999.00 should a 1099 form for IRS be submitted? Suggestion was made that at future events instead of a 50/50 type raffle we have a cash raffle and advertise as such. Board will review. Chairman of Gun Banquet Arlyn Libal thanked everyone for another successful banquet.

Sunshine Report (chairperson) Cindy Brokiewicz: Nothing to Report.

Next Up: Dave Gross of the Brazeau Dive Team was our guest speaker. Dave does an excellent job keeping the club updated on their activities and efforts. The Dive Team had purchased a different mobile dive equipment unit which was present at the 2018 KLSC Ice Fishing Derby. The Dive Team volunteers their time to stand by at the derby in case needed. They also have obtain the old Brazeau Ambulance building on Parkway and 64 and they have been busy painting, cleaning and maintaining that building. Brazeau Dive Team also checks KLSC fish sticks and old cribs in Kelly Lake for the club and the DNR. Dave will have pictures of cribs at next club meeting and reports he has seen a lot of fish around the fish sticks, especially crappies. The team also volunteers for our Ice Derby Meat Raffle. A club donation of \$750.00 was presented to Dave Gross for the Brazeau Dive Team.

Veterans Program (chairperson) Glen Bouchard not present, however, Arlyn Libal reminded club members that KLSC is still working on a pledge to Vets 4 Vets of Northeast Wisconsin for a Memorial to be built in Suring, WI. Club will not pursue pontoons this year for fishing however anyone wishing to volunteer their pontoon/boat and take kids out on lake please see Pam or Cindy the day of the derby. DNR does not however support the stocking of Bluegill. DNR will stock walleye this year, with the help of KLSC.
